PARTICIPANT RELEASE OF LIABILITY and ASSUMPTION OF RISK **Please Read Carefully**

For purposes of this release document ("this Release"), "Event" means collectively the "FRIENDS OF THE LEE'S SUMMIT SYMPHONY 5K RUN/WALK (MOVIN' FEET TO THE SYMPHONY BEAT)" event being held in and around Unity Village, Missouri, on Saturday, April 14, 2012, any transportation provided to, from or during that event, and any other activities related to that event. In consideration of the opportunity to participate in the Event, I, the undersigned participant (the "Participant"), acknowledge and agree that:

1. Participation in or attendance at the Event involves inherent risks and dangers of accidents, personal and bodily injury (including death) and property loss or damage. These may result from my own actions or inactions, as well as the actions or inactions of others, the rules of play, and the condition of the facilities and equipment. Further, there may be other risks not known to me and not reasonably foreseeable at this time. I have considered the nature and extent of the risks involved, and I voluntarily choose to assume all such risks, both known and unknown, even those risks that result from the negligence of the Released Parties (defined below) or others and assume full responsibility for my participation in the Event. I consent to treatment in the event of an emergency or other incident in which, in the reasonable judgment of the on-site personnel, I require medical care.

2. I hereby grant to the Lee's Summit Symphony Orchestra, its affiliates, subsidiaries, successors, agents, assigns and licensees (collectively the "Recorders") permission to film, photograph, videotape or otherwise record my image, voice, or any other aspect of the recording at the Event (collectively, the 'Recording') and to use the Recording and my name in any manner or media and for any purposes without any

additional consideration. I shall have no right of approval and no legal claim arising out of any use or editing of the Recording or my name. The Recorders shall have no obligation to use any of the rights I grant. I represent that it is not necessary for the Recorders to obtain permission from or to pay any fees to me or to any third party in connection with the rights granted in this paragraph.

3. I, for myself and on behalf of my heirs, estate, insurers, successors and assigns, hereby release, indemnify and hold harmless the Lee's Summit Symphony Orchestra, the Friends of the Lee's Summit Symphony Orchestra, all other Event sponsors and advertisers, all Event workers, volunteers, their representatives, successors and assigns, respective officers, directors, shareholders, employees, agents and insurers, and all owners or lessors of premises used in connection with the Event (collectively the "Released Parties") with respect to any and all claims or causes of action I may have for damages for personal or bodily injury, disability, death, loss or damage to person or property relating in any way to the Event, whether arising from the negligence of any or all of the Released Parties or otherwise, to the fullest extent permitted by law. I understand and agree that the Event director reserves the right to cancel the Event in case of emergency.

I have read this Release, fully understand its terms and understand that I am giving up substantial rights by signing it. I sign this Release freely and voluntarily, without any inducement or coercion. It is mandatory to complete this section. **I certify that I am over 18 years of age or I have my parent's or legal guardian's consent as indicated below.** I understand that entries are non-refundable and non-transferable.
